RECOMMENDED ACTION

Staff recommends that the Senior Citizens' Advisory Board (S.C.A.B.) receive and file this program update.

SUMMARY

- Senior Center attendance September 2024: 4,079, averaging 203, (August 2024: 4,365)
- Senior Center membership end of September 2024: 4,126
- Meals delivered in September 2024: 2,800 meals to 400 seniors, averaging 100 seniors per week.
- Hot lunches served September 2024: 2,036 averaging 101 per day. (August 2024: 2,222, averaging 101 per day)
- FSA continues to take home meals on weekends for seniors.
- Feeding America distributed (400 food boxes of non-perishable food boxes on October 10, 2024, Senior Center continues to lead the I.E., in boxes distributed to seniors. Starting November 14, 2024, the Food Distribution will be moving to the Conference and Recreation Center (CRC).
- The Center continues to stay open as a cooling center when temperatures go above 98 degrees.
- The Center's banquet room continues to average two banquet rentals a month and two church rentals every Sunday and two classroom rentals weekly.
- Healthcare agencies will be on site at the Senior Center as open enrollment approaches.
- Friends of Moreno Valley continues its partnership with the Salvation Army to provide 36 seniors with perishable food items. Distribution will be every Friday.
- Friends continues providing free shuttle service to seniors for all medical and grocery needs as well as free coffee.
- Haircuts continue to be full at the senior center every Tuesday. Appointment required.
- Headsets continue to be available for all meetings for hard of hearing and/or translation as needed. Translation Requests must be submitted at least 72 hours prior to need.
- CPR class has resumed, and the signup sheet is available.

 - Senior Soaring Newsletter, available at the front counter.
 - Ads on our monitor in the lobby continue to be updated. A lot of them include a QR code with more details.
