







Investigations Team

The Moreno Valley Station's Investigations and Evidence Bureau serves the city of Moreno Valley, as well as a section of the surrounding unincorporated area of Riverside County. The Investigations Bureau is comprised of one Sheriff's Lieutenant, two Sheriff's Sergeants, and twelve dedicated Investigators assigned to various specialties such as robbery, assaults, sex crimes, child abuse, property crimes. There are also two dedicated Deputies, and one Community Service Officer assigned to missing persons, runaway juveniles, domestic violence investigations, and Children Services Division/Adult Protective Service referral investigations.

Sex Offenders | Arson Offenders

The Moreno Valley Sheriff Station 290 Registration Unit consists of one Deputy Sheriff and one Community Service Officer. The unit currently has 400 allocated hours per fiscal year for compliance checks of sex/arson registrants. Due to the limited hours assigned to the unit, compliance checks are conducted every other month.

The team's duty is to conduct sex & arson offender (including Parole / Probation offenders) compliance checks, investigate related violations, conduct and manage PC290 sweeps, registration events, and assist investigators and deputies with complex PC290 investigations. In addition, the team is responsible for massage parlor inspections and massage therapist license checks. The team also issues massage & secondhand business operational licenses and conduct stolen property investigations with pawn shops.



On August 21, 2024, the Moreno Valley Sheriff's Station Investigations Bureau with the assistance of Riverside County Probation and the California Department of Corrections and Rehabilitation Parole Division, conducted Sex Registrant Compliance checks in accordance with Penal Code Section 290. The compliance checks were conducted on registrants that fall within the area of responsibility of the Moreno Valley Sheriff's Station. One hundred seventeen registrants and sixty-five locations were checked to ensure they were in compliance with their sex offender registration requirements. Offenders who were on probation or parole were also checked to confirm compliance with their court-ordered terms.

Nine subjects were arrested for violating their probation or parole terms, as well as various felonies, including narcotics-related charges and unlawful possession of ammunition. Four registrants were found to be out of compliance. Further investigation will be conducted on each registrant in violation of their registration requirements, and charges will be filed with the Riverside County District Attorney's Office.





Community Behavior Assessment Team

CBAT is a cooperative agreement between RUHS-Behavioral Health and Riverside Sheriff's Department partnering a Clinical Therapist and Deputy Sheriff to assist with crisis mental health services in response to 911 calls. Services include mental health crisis assessments, attempt to divert those in crisis to the lowest level of necessary care, and link those people to outpatient mental health services in an attempt to reduce recidivism.

Notable Cases

On Tuesday August 27, 2024, Moreno Valley CBAT responded to a 911 call for service in which the caller was not making sense to dispatch. The caller was frantic, reporting he was unable to see his mother's arms and legs. Upon arrival, CBAT spent time developing rapport and assessing risk. The caller was found to be living alone and experiencing paranoid delusions, including delusion of his neighbors following him with intent to do him harm. Client's psychosis was causing subject intense distress. CBAT provided subject with risk assessment, finding him not meeting criteria for a 5150 hold at that time, however linked him to Mental Health Urgent Care Services in Perris. Subject is now receiving on-going follow-up services from RUHS-BH Mobile Crisis team.

SPECIAL TEAMS

RBST | GANG | SET | POP | HOT Teams

The Moreno Valley Station Special Teams consist of RBST, SET/GANG and POP/ HOT Teams. The Robbery and Burglary Suppression Team (RBST) actively investigate all robberies, carjackings, thefts, and burglaries occurring in the jurisdiction of the Moreno Valley Station. The main goal of the Special Enforcement Team (SET) is to enhance quality of life for Moreno Valley residence by investigating violent and gang related crimes and to bring cases to a successful conclusion by identifying, apprehending, interviewing, and arresting suspects. The Problem Oriented Policing (POP) team respond to a variety of calls from citizens of Moreno Valley that may fall outside the normal patrol function. POP deputies conduct proactive investigations into narcotics trafficking, human trafficking, marijuana cultivation and vehicle theft with a nexus to Moreno Valley. The Homeless Outreach Team (HOT) team responds to calls from business owners and citizens regarding transient activity.

Recovery of Stolen Cargo

The Moreno Valley Sheriff's Station Special Enforcement Team (SET) has conducted an investigation since February 2024 into an organized retail crime and trailer cargo theft ring. On August 2, 2024, around 12:20 p.m., Moreno Valley Sheriff's Station SET deputies served a search warrant on a warehouse located in the 3400 block of De Forest Circle in Jurupa Valley. Over 300 pallets of stolen merchandise, ranging from small appliances to high end gaming computers, were seized during the service of the search warrant. Deputies detained 33-year-old Yong Li during the search warrant. Li was later arrested for receiving stolen property and an aggravated white collar crime enhancement. This is an ongoing investigation, and no additional information is available at this time.

HOMELESS OUTREACH

SPECIAL TEAMS - AUGUST

On 08/22/2024, the Moreno Valley Special Teams conducted a "Homeless Sweep Quality of Life Operation" throughout the City boundaries, alongside city resources which included the following: Maintenance and Operations, Riverside Sheriff's Department, Parks Maintenance, Riverside County Mental Health and The Salvation Army. The teams responded to 11 different locations including CRM's concerned areas. The operation assisted 16 individuals and out of those individuals 2 accepted services from The Salvation Army and Riverside County Mental Health. A total of 1 individual was arrested.



On 08/08/2024, the Moreno Valley Special Teams conducted a "Homeless Sweep Quality of Life Operation" throughout the City boundaries, alongside city resources which included the following: Maintenance and Operations, Riverside Sheriff's Department, Parks Maintenance and The Salvation Army. The teams responded to 10 different locations including CRM's concerned areas. The operation assisted 13 individuals and out of those individuals 4 accepted services from The Salvation Army. A total of 1 individual was arrested.

TRAFFIC TEAM

Moreno Valley Station

The Moreno Valley Station Traffic Bureau is subdivided into three teams, Commercial Vehicle Enforcement, Accident Investigations and Motor Traffic Enforcement, who collectively maintain safety for drivers on the roadways of Moreno Valley through enforcement, education and engineering. Deputies and Community Service Officers assigned to Accident Investigations are responsible for investigating traffic collisions, which include property damage only collisions, minor-injury traffic collisions, major-injury traffic collisions, fatal traffic collision, hit-and-run collisions, and then taking appropriate enforcement actions based on the outcome of each investigation. The Commercial Vehicle Enforcement Team's responsibilities include conducting commercial vehicle compliance checks (state, federal and international laws), enforcing applicable commercial vehicle laws and municipal codes, perform roadside safety compliance checkpoints and working with allied agencies to help maintain roadway safety regionally. The Motor Enforcement Team maintains safety on the roadways within the jurisdiction of Moreno Valley through the enforcement of those violations identified as primary collision factors and by providing education to the motoring public. Collectively, the Traffic Bureau conduct school zone traffic enforcement, DUI enforcement saturation patrols, distracted driver enforcement, pedestrian safety enforcement, street racing enforcement, while also working to eliminate issues negatively affecting the quality of life for the citizens of Moreno Valley. Additionally, the Moreno Valley Traffic Bureau conducts presentations and training for the citizens of Moreno Valley to provide education in efforts to improve safety on city roadways and actively collaborates with City of Moreno Valley traffic engineers to identify traffic safety concerns throughout Moreno Valley and develop solutions.

Driving Under the Influence (DUI) Check Point

The Moreno Valley Station Traffic Team conducted a Driving Under the Influence (DUI) / Driver's License checkpoint on Friday, August 23, 2024. The checkpoint was on Heacock Street and Webster Avenue, between the hours of 8:00 PM and 2:00 AM.

Checkpoint Results:

524 vehicles screened.

- 3 Field Sobriety Tests (FSTs) conducted.
- 1 arrested for driving under the influence of alcohol.
- 1 arrested for miscellaneous misdemeanors.
- 16 citations issued for driving without a driver's license.
- 1 citation issued for driving with an expired license.
- 2 vehicles were stored or impounded.
- 1 arrested for an outstanding felony warrant.

DUI checkpoint locations are determined based on reported incidents of impaired driving-related crashes. The primary purpose of DUI checkpoints is to promote public safety by taking suspected impaired drivers off roads. Funding for this checkpoint was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

Notable Cases for August

- Deputies responded to a report of a female at RUHS who claimed she had been assaulted by her boyfriend in his vehicle at various locations for several days. On 8/9/24, the victim managed to take control of the vehicle when the suspect exited and fled the area. FLOCK and Citywide cameras were used to assist in the investigation.
- Deputies responded to a shooting which turned into a homicide. During the investigation Deputies discovered the Suspect drove away in a vehicle. Deputies put the plate number into the Flock system and later located the vehicle.
- Deputies were alerted via Flock cameras that a stolen vehicle was in the area. Deputies located the stolen vehicle and took the suspect into custody.



The Moreno Valley Community Services Unit (CSU) operates under the Station Administration and administers numerous proactive programs designed to educate the public and reduce crime. The Community Services Unit consist of two Deputies and one Community Service Officer. The Community Services Unit plays a key role in the ongoing safety and wellbeing of our citizens by being involved in the community. The Community Service unit is responsible for coordinating neighborhood watch programs, Ride Along Program, the Crime Free Multi Housing Program currently being re vamped), Crime Free Through Environmental Design (CPTED), Terrorism Liaison, Volunteer and Explorer programs, Community Programs and events (Cops and Clergy, Active Shooter Training, Coffee with a cop, Zone Meetings etc.), New Hire orientation, Operation Holiday Cheer, National Night Out. The Community Services unit serves as a liaison between the community and the City of Moreno Valley (City Council Meetings, Alarm citations, ABC, Planning, Parking Citations).
