| 1.  | <b>CITY OF MORENO VALLEY - PROGRAM ADMINISTRATION – (951) 413-3450</b><br>The City of Moreno Valley manages the overall CDBG grant program and reports to the Office of Housing and Urban Development on program outcomes. This includes project selection, overseeing of sub recipients, environmental reviews, special studies, program reporting and monitoring of all awards.   | \$416,405 |
| 2.  | <b>ASSISTANCE LEAGUE OF RIVERSIDE- OPERATION SCHOOL BELL- (951) 684-1703</b><br>Operation School Bell is a program provided to elementary, middle school and high school students with a goal of assisting them in removing barriers to learning. Since 1967 they have provided new school clothes, backpacks, school supplies, hygiene kits and reading books to homeless and economically disadvantaged children.   | \$15,000  |
| 3.  | <b>FAIR HOUSING COUNCIL- FH ANTI-DISCRIMINATION SERVICES/LANDLORD TENANT COUNSELING (951) 653-8314</b><br>Provides comprehensive services which affirmatively address and promote fair housing/anti-discrimination rights and further other housing opportunities for all. This is accomplished through three component areas including education, training/technical assistance and enforcement.   | \$57,672  |
| 4.  | <b>FAMILY SERVICE ASSOCIATION (FSA) – SENIOR NUTRITION PROGRAM – (951) 342-3057</b><br>Provides case management for the Senior Nutrition Program which provides one nutritionally balanced meal Monday-Friday. The meals are provided to seniors 62 years of age and older in a group setting at the Moreno Valley Senior Center. Meals are also provided through an in-home delivery service to homebound seniors/elderly to help with basic nutritional needs and well-being. | \$20,000  |
| 5.  | <b>FRIENDS OF MORENO VALLEY SENIOR CENTER – MO-VAN SENIOR TRANSPORTATION PROGRAM – (833) 745-8454</b><br>The “Mo-Van” offers transportation services to senior citizens over the age of 60 and disabled adults to the Moreno Valley Senior Center and to medical and other non-emergency appointments, including the monthly Farmers Market and local grocery stores at a low cost.   | \$55,000  |
| 6.  | <b>GRID ALTERNATIVES – LOW INCOME SOLAR ENERGY ASSISTANCE PROGRAM- (951) 471-7045</b><br>This project will install solar electric systems for low-income residents of Moreno Valley and will provide roof repairs to make homes “solar ready” for qualified homeowners.   | \$75,000  |
| 7.  | <b>HABITAT FOR HUMANITY –A BRUSH WITH KINDNESS – MOBILE HOME REPAIR (951) 787-6754</b><br>Designed to help low and moderate income households in mobile home communities to make necessary exterior improvements to their dwellings such as skirting, trim, steps, entrance and porch deck repairs.   | \$10,000  |
| 8.  | <b>HOPE VISION CENTER – HOPE SUMMER ACADEMY – (951) 452-2027</b><br>Provides low to moderate income K-12 <sup>th</sup> grade students in Moreno Valley with a free or low cost, high quality summer academy in which they will receive academic intervention and enrichment activities.   | \$10,000  |
| 9.  | <b>OPERATION SAFE HOUSE – EMERGENCY SHELTER FOR YOUTH – (951) 351-4418</b><br>Provides services to runaway, homeless, and at-risk youth between the ages of 11-17 including a shelter/safe house, life skills classes, educational tutoring, meal preparation, 1-800 crisis line assistance, and transportation.  | \$10,000  |
| 10. | <b>RIVERSIDE AREA RAPE CRISIS CENTER – CHILD ABUSE PREVENTION PROGRAM –(951) 686-7273</b><br>Provides primary prevention education for Moreno Valley schools, grades K-12, including Special Education and bilingual classrooms. The program educates students, parents and teachers on facts of physical, verbal, sexual abuse and neglect.  | \$14,454  |
| 11. | <b>SMALL BUSINESS DEV CENTER (University Enterprises Corp) - IE SMALL BUSINESS DEV. – (951) 781-2345</b><br>Provides one-on-one confidential business counseling sessions with existing and startup small businesses. Will conduct workshops and help low-to-moderate income individuals with free consulting services and group training.  | \$33,900  |
| 12. | <b>THE SALVATION ARMY- NEIGHBORHOOD CLEAN-UP PROGRAM- (951) 653-9131</b><br>Provides at least 90 days of clean up services throughout the City of Moreno Valley. Clean-up sites will be identified by Waste Management. Employees will be transported and supervised by the Salvation Army.   | \$30,000  |
| 13. | <b>U.S. VETERANS INITIATIVE – VETERANS IN PROGRESS – TRANSITIONAL HOUSING ASSISTANCE –(951) 999-9120</b><br>This program is an intensive case management program for low-income and homeless veterans who have the desire and ability to return to the workforce. The residential program provides counseling, skills development, job finding, and job retention skills training.  | \$30,000  |

| 14. | <b>VOICES FOR CHILDREN – COURT APPOINTED SPECIALADVOCATE (CASA) PROGRAM – (951) 472-9301</b><br>Provides a volunteer Court Appointed Special Advocate to 15 foster children for a full year.   | \$30,000  |
| 15. | <b>MORENO VALLEY POLICE DEPT – COMMUNITY BETTERMENT –POP BASED POLICING – (951) 486-6700</b><br>Designed to help Sworn MVPD personnel work assigned overtime hours in CDBG target areas to enhance the Community-Oriented Policing philosophy. The purpose is to reduce crime within the areas, remove blighted conditions, and improve quality of life for the community. | \$70,177  |
| 16. | <b>CITY OF MORENO VALLEY – CAPITAL IMPROVEMENT PROJECT PAVEMENT REHAB – (951) 413-3130</b><br>This project will provide pavement rehabilitation for a total of approximately 70 local streets within the City's HUD-CDBG Low/Mod Census Tract areas.   | \$854,416 |
| 17. | <b>CITY OF MORENO VALLEY – FLAMING ARROW STORM DRAIN – (951) 413-3740</b><br>This project will provide 1200 linear feet of 24-inch diameter pipe starting from north of the Bay Avenue/Flaming Arrow Drive intersection where the 24-inch diameter pipe will tie into the existing 42-inch diameter Line M-11 pipe.  | \$250,000 |
| 18. | <b>CITY OF MORENO VALLEY – ADA IMPROVEMENTS AT CITY FACILITIES – (951) 413-3740</b><br>This project consists of improvements to various City Facilities including corrective actions to meet ADA requirements such as restroom upgrades, re-striping of accessible parking spaces, installation of ADA accessible path of travel, reach ranges and door pressures.         | \$150,000 |

| 1. | <b>HOME PROGRAM ADMINISTRATION – (951) 413-3450</b><br>The City of Moreno Valley manages the overall HOME grant program including project selection, overseeing of sub recipients, environmental reviews, special studies, all program reporting and monitoring.  | \$67,217  |
| 2. | <b>CHDO (COMMUNITY HOUSING DEVELOPMENT ORGANIZATION) HOUSING – (951) 413-3450</b><br>Each year HUD requires that 15% of the annual allocation be reserved for affordable housing projects to be developed by a Community Housing Development Organization (CHDO).   | \$100,825 |
| 3. | <b>HABITAT FOR HUMANITY – A BRUSH WITH KINDNESS - MOBILE HOME REPAIR – (951) 787-6754</b><br>This program provides a grant of up to \$12,500 to income qualified owner-occupants of mobile homes to make necessary repairs both interior and exterior. Repairs will first address correction of code, health and safety violations.   | \$225,000 |
| 4. | <b>HABITAT FOR HUMANITY – A BRUSH WITH KINDNESS - SINGLE FAMILY HOME REPAIR – (951) 787-6754</b><br>This program provides a grant of up to \$15,000 for interior and exterior minor repair services for single family residence homeowners in need. Home preservation services include plumbing, electrical, flooring, air conditioning, kitchen repairs, painting, roof repairs, handicap ramps, landscaping, and other minor repairs. | \$395,000 |

| 1  | <b>ESG PROGRAM ADMINISTRATION – (951) 413-3450</b><br>The City of Moreno Valley manages the overall ESG grant program including project selection, overseeing of sub recipients, environmental reviews, special studies, all program reporting and monitoring.  | \$13,366 |
| 2. | <b>CATHOLIC CHARITIES OF SAN BERNARDINO &amp; RIVERSIDE-CASEWORK SERVICES PROGRAM – (909) 388-1239</b><br>Provides case management services to homeless and those at risk of homelessness, including community outreach, homeless prevention services, motel vouchers, rental assistance (rent in arrears to prevent eviction), utility assistance, food and other supportive services. | \$69,848 |
| 3. | <b>COUNTY OF RIVERSIDE- HOMELESS MANAGEMENT INFORMATION SYSTEM (HMIS) –(951) 358-5636</b><br>City contribution to support the ESG client tracking software required by HUD for grant data collection and reporting.   | \$5,000  |
| 4. | <b>SOCIAL WORK ACTION GROUP – HOMELESS STREET OUTREACH PROGRAM – (951) 496-8790</b><br>Provide consistent and effective homeless street outreach services to those who are truly vulnerable on the streets of Moreno Valley.  | \$90,000 |
